Items may be viewed during the time period of Monday, July 13 through Thursday, July 16. Sealed bids for the sale of the items will be accepted until 2:00 pm, Tuesday, July 21 at the Purchasing Office. All bid response envelopes must be marked with "Surplus Property Bid 5574" on the outside. It is the responsibility of the bidder to ensure that the bid is received in the proper location on or before the stated due date and time.

All items will be sold to the highest bidder. Successful bidder must pay for all equipment purchased on or before Monday, July 27, 2015 at the Cashier's office, second floor, Student Center Building. Payment will be accepted by cash, VISA, MasterCard, Discover, money order or cashier's check only. NO personal checks will be accepted. Successful bidder must remove all property from campus by 5:00 pm, Friday, July 31, 2015.
